Sutler/Vendor Regulations-

1. All sutlers must be pre-registered by deadline. No walk-ons will be allowed
2. Set up will begin at 8am on Friday, March 9, 2012 . All vehicles & trailers must be removed from Sutler area before 5pm.
3. Only authentic sutleries will be allowed within the Time Line. This is defined as a person or persons in period dress, selling period goods from a period structure, where said goods are for the direct use of the reenactors in their living history impressions. All other vendors will be separated outside the Time Line. These vendors may sell their wares only from their assigned booth.
4. All sutlers, their employees and/or dependents that work in the Sutler area must be dressed appropriately in period dress. Modern dress will only be allowed during set up and take down.
5. All vehicles must be out of the Sutler area before you will be allowed to open for business. No deliveries will be allowed by vehicle during the event. No vehicle, including campers and trailers, will be allowed to stay in Sutler area without prior consent of the Sutler Coordinators.
6. All modern equipment, tables and displays must be disguised within the Time Line. Non period correct lighting should not be visible.
7. No open fires will be allowed in the Sutler or vendor areas. All sutlers must have a fire extinguisher on site.
8. Trash bins will be provided. Please police your area before departure, bag and place all refuse in these containers.
9. Booth space may not be shared without prior consent from the Sutler Coordinators.
10. Inappropriate behavior WILL NOT be tolerated. Sutlers or vendors deemed a nuisance by the Sutler Coordinators or CWCT staff during the event shall be removed from the premises.
